COMET FLASHBACK ARRESTORS

The COMET range of Flashback Arrestors provide the perfect option for those looking to safeguard against flashbacks, backfires and sustained backfires, in a situation where extremely high gas flows are not required.

A flashback occurs when mixed gases within a cutting and welding blowpipe system ignite and burn back through the system against the flow of gas. The consequences of a flashback range from sooting of the hose, to serious equipment fires and possible explosion. The flashback can travel at supersonic speeds - faster than the operator can turn off the cylinder! So, if you hear a loud "pop" or "bang" then flashback has already occurred. Flashback arrestors when used & fitted correctly virtually eliminate the possibility of a flashback causing harmful damage.

Provides protection against flashbacks, backfires and sustained backfires

- NV Non-Return Valve prevents reverse flow of gases
- FA Stainless Steel Flame Arrestor extinguishes any returning flame
- **TV** Gas flow will be shut-off if arrestor becomes overheated
- **DF** Dust Filter protects the gas non-return valve against contamination
